The District reserves the right to evaluate the evidence presented and merely presenting the items listed does not guarantee admission. **If a student is determined to be a nonresident of the District for whom tuition must be charged, the persons enrolling the student are liable for nonresident tuition at a rate of \$8,064.96 per year from the date the student began attending a district school as a nonresident.** A person who knowingly enrolls or attempts to enroll in this District on a tuition-free basis a student known by that person to be a nonresident of the District is **guilty of a Class C misdemeanor**, except in very limited situations as defined in State law (105 ILCS 5/10-20.12b(e)). A person who knowingly or willfully presents to the District any false information regarding the residency of a student for the purpose of enabling that student to attend any school in that District without the payment of a nonresident tuition charge is **guilty of a Class C misdemeanor** (105 ILCS 5/10-20.12b(f)).
